EXECUTIVE SUMMARY

Science Engagement to Empower Disadvantaged AdoleScents (SEEDS) aims at fostering science interest, literacy and STEM (Science, Technology, Engineering and Mathematics) education, by raising the health understanding, also pursuing the empowerment of youth in an extreme citizen science based on the participation of leader' adolescents in all the research process: identifying adolescents barriers and necessities for having a healthy lifestyles, designing a community-based public intervention for adolescents of low-socioeconomic areas and with stakeholders participation, interpretation of the data and dissemination to community.

The present document provides an overview of the good practice guidelines for SEEDS Consortium members concerning ethical standards. It details key steps and procedures in relation to carrying out SEEDS project to a high standard and in accordance with European and internal guidelines for ethical conduct in research practice.

This document may be updated during the lifecycle of the project if needed, introducing further information as Milestone actions get finalised and reported.

















1. INTRODUCTION

Ethics is given the highest priority in European Union (EU) funded research and all SEEDS activities will be conducted according to national legal and ethical requirements for participant countries in: Germany, Greece, The Netherlands, Spain and The United Kingdom. Moreover, SEEDS will comply with the Horizon 2020 ethical principles¹ and guidelines and with Regulation 2016/679 (entered in force on 25th May 2018) regarding the GDPR (General Data Protection Regulation) compliance². Also, this project is carried out under the Charter of Fundamental Rights of the EU (2012/C 326/02)³ and the European Convention on Human Rights⁴.

Good research practice is based on the integrity, rigour, and ethical conduct. The following guidelines intent to aid all SEEDS team members during the project and promote a shared understanding of the importance of high standards in research and adherence to guidelines concerning ethical conduct in research. They complement the rules for participation and dissemination outlined in the SEEDS Consortium agreement:

- The European Commission's comprehensive guidelines Ethics for Researchers: Facilitating Research Excellence in Seventh Framework Programme FP7 (2013)⁵;
- 2. The European Code of Conduct for Research Integrity: Revised Version (2017)6; and
- Best Practices for Ensuring Scientific Integrity and Preventing Misconduct, a set of guidelines issued by The Organisation for Economic Co-operation and Development (OECD)'s Global Science Forum (2007)⁷.

Moreover, SEEDS project follows the national and organizational regulations shown in Table 1.

2. GOOD RESEARCH PRACTICE GUIDELINES

The SEEDS Consortium joints a group of experienced researchers of different European countries, and all of them agree to adhere to the principles of integrity of research and good practice in research throughout the entire project. The European Code of Conduct for Research Integrity: Revised Version, issued in 2017⁶, provides good research practices based on the four principles of integrity in research:

- Reliability for ensuring the quality of research: based on the design, methodology and the analysis of the use of resources.
- Honesty for developing, undertaking, reviewing, reporting, and communicating research in a transparent, fair, full, and unbiased way.
- Respect for workmates, participants in the research, community, and society.
- Accountability for the research from idea to publication, for its management and organization, for training, supervision, and mentoring, and for its wider impacts.

2.1. Good research practices in different research contexts applied to SEEDS project

The Good Research Practices are defined by different research contexts into specific activities that will be developed in SEEDS project:

- a) Research environment: Research institutions and organizations participating in the Consortium of SEEDS project will ensure the prevailing culture of research integrity, the provision of clear policies and procedures on good research practice, the support of proper infrastructure for the data management and data protection, and the reward hiring and promotion of researchers when they applied open and reproducible practice.
- b) Training supervision and mentoring: Research institutions and organizations participating in the Consortium of SEEDS project will ensure that researchers received rigorous training in research (design, methodology and analysis of data) and in ethics integrity.
- c) Research procedures: Researchers from the SEEDS project will take into account the state-of-the art in developing research ideas, design and analyse the project and specific activities carefully and in a well-considered manner, use the research funds properly, respect the data confidentiality and publish results in an open-access and transparent manner, and they reported the results in a reproducible way.
- d) **Safeguards**: Researchers from the SEEDS project will comply with the discipline' codes and regulations, address human subjects with respect and care based on ethical SEEDS guidelines, considering health, safety and welfare of the community and project' participants (adolescents and stakeholders), be sensitive considering the differences among participants (ethnic, religion, age, culture, gender and socioeconomic level), and manage the risks and harms of the SEEDS research. This information is extended in **Deliverable 6.3**.


















- e) Data practices and management: Researchers and organizations participant in the SEEDS project will ensure appropriate data protection, open-access data when it is possible, be transparent on how to access or use this data, acknowledge data is legitimate and citable products of the research, ensure the protection of intellectual property in any contracts and agreements relating to research outputs. This information is extended in Deliverable 6.4.
- Collaborative working: Researchers of the SEEDS project in their research collaborations will take responsibility for the integrity of the research, agree at the beginning the goals of the research, the process to communicate it, the laws and regulations that apply them, and properly informed of the submission of results publications.
- Publication and dissemination: All authors of the SEEDS project will be fully responsible for the content of the publications derived from the project, agree on the authorship publications guidelines specified in the Grant Agreement and Project Management Handbook of the SEEDS project, acknowledge their work to others (collaborators, assistants and funders), disclose any conflicts of interest and financial or other types of support for the research or for the results' publication, commit to correct or retract work if necessary, consider negative findings as valid as positive results for publication and dissemination and, made available their work related to the project timely, open, transparent and in an accurate manner.
- Reviewing, evaluating, and editing: Researchers of the SEEDS project will commit to participate in refereeing, reviewing and evaluating submissions for publications, funding, appointment, promotion, or reward in a transparent and justifiable manner. Moreover, reviewers or editors with a conflict of interest will withdraw from the publication decision, funding, appointment, promotion or reward and they will maintain the confidentiality unless approval for disclosure was prior.

















3. SEEDS ETHICAL GUIDELINES

SEEDS consortium members are fully aware of the ethical issues involved in their work with human participants and commit to taking care to follow the general ethical principles of the scientific code of conduct: avoidance of exploitation, just distribution of benefits and burden, beneficence, respect for persons, respect for human dignity, scientific validity, social value and the rights and interests of research participants.

The project sets up '**Privacy by Design**' rules to guarantee that all research activities address security, ethics and individuals' liberties. The SEEDS project will enable mechanisms to avoid any intentional or unintentional use of information that can bring any harm to any participant or being misused in other contexts. The ethical standards and guidelines of Horizon 2020¹ will be rigorously applied, regardless of the country in which the research is carried out.

Considering the activities of the SEEDS project that could arise ethical issues, these activities must comply with the following ethics requirements:

- Humans (H)- Requirement No.1: Templates of the informed consent/assent forms and information sheets (in language and terms intelligible to the participants) submitted as deliverables before the commencement of the relevant research.
- Protection Of Personal Data (POPD) Requirement No.3: The host institution confirms in the
 Grant Agreement that it has appointed a Data Protection Officer (DPO) and the contact details
 of the DPO will be made available to all data subjects involved in the research. For host
 institutions not required to appoint a DPO under the GDPR regulation², a detailed data
 protection policy for the project is submitted as a deliverable.
- H- Requirement No.6: Copies of opinions/approvals by ethics committees and/or competent
 authorities for the research with humans will be submitted as a milestone prior to the
 commencement of the relevant research.
- POPD Requirement No. 11: The beneficiary evaluates the ethics risks related to the data processing activities of the project. This also includes an opinion if data protection impact assessment should be conducted under art.35 GDPR⁸.
- POPD Requirement No. 12: The confirmation that the transfer of personal data from a non-EU country to the EU (or another third state) comply with the laws of the country in which the data was collected.

Before the beginning of an activity raising an ethical issue, each beneficiary must have obtained:
(a) any ethics committee opinion required under national law and (b) any notification or authorisation for activities raising ethical issues required under national and/or European law needed for implementing the action tasks in question.

















3.1. Ethical board

The Executive Board (EB) is composed by the Project Coordinator (PC), the Quality and Ethics (Q&E) Manager, the Dissemination and Communication (D&C) Manager, and the Innovation Manager (IM).

The Q&E Manager, represented by Lucia Tarro and Elisabet Llauradó from **IISPV**, has the responsibility of dealing and monitoring ethical aspects throughout the duration of the project as well as overseeing the promotion of gender equality and assessing relevant ethics and gender issues entailed by the project, with the mission of protecting the rights, equality, security and welfare of the participants in the project. Q&E Manager also supports the PC in ensuring the scientific and technical quality of the project, and more specifically, include the following activities:

- Monitor the quality of the technical roll-out of the work plan and adopt actions to correct deviations;
- Supervise and ensure the quality of the preparation of deliverables and of documents;
- Ensure the consistency of the project reports and deliverables delivered to the EC.

3.2. Main ethical issues

3.2.1. Data collection and interviews

The ethical aspects in data collection and interviews procedures must be considered carefully. A Data Management Plan (DMP) will be developed in the first months of SEEDS project by University of Exeter (UoE) as deliverable D6.2. The DMP will define the methodology, procedures, and measures to be performed throughout the different project phases. Moreover, the DMP will specify the accessibility of data, data usability, and sustainability of this data.

Data of the participants will be collected in different formats:

- Focus Groups (interviews): The Focus Groups will be carried out by groups of adolescents, named ambassadors, and by a group of stakeholders in each country. Focus groups will be conducted online considering the COVID-19 pandemic situation, and for this reason the protection of individuals and rights law will be extremely applied. When the focus groups are implemented online, there are specific considerations depending on the country (Table 2). Considering these matters, the focus groups will be conducted under the following principles:
 - o All participants and their parents must sign an informed consent.
 - Requirement of the presence of an adult (teacher at participant high school, community worker or another trusted person) in the videoconference with adolescents.
 - Each interview will be audio recorded and stored with a number code; the audio file will never be shared with other countries.

















- Image will not be recorded, only the voice of participants in the focus groups. After transcription, all voice-records (audio files) must be keep stored in a folder with restricted access to one person of the research group to ensure their confidentiality within the duration of the project.
- The transcriptions will be codified, and therefore will not contain names of the participants.
 The school, gender and age of the respondent will be available.
- As adolescents will belong to low socio-economic level, stigmatization should be avoided, and researchers will not mention their socio-economic level situation during the interview.

The United Kingdom	Regular school-based safeguarding approaches will be followed by the UOE team, this means we will have a full Disclosure and Barring Service check that we will present to each school we are in contact with. In addition to this we will: familiarise ourselves with each schools' safeguarding policy, including how to report a potential safeguarding concern, read the first chapter of the statutory guidance in the Government paper 'Keeping Children Safe in Education', and feedback to relevant members of the school staff about the progress of the research. Focus Groups are conducted using a text-based platform, where participants type their responses. 2) Focus Groups are conducted over a video conferencing program, such as Microsoft Teams, this would enable participants and the research team to see one another. 3) Focus Groups are conducted over a video conferencing platform, and the ability to see one another is removed, or the focus groups are conducted in the format of a conference call. We will collaborate with each school to determine which above method is most appropriate. However, we will insist that an appropriately trained member of staff is present for the duration of the focus group as a 'comoderator' to ensure safeguarding is always maintained. There is the possibility that each school might want to view the document of the focus groups given the proposed methodologies – we need to accommodate this. This is going to be where the co-moderator will also play a role in the focus	
	groups. UOE staff having the email details of individual pupils is a safeguarding concern, however, there is nothing wrong in UOE staff having	















access to adult members of staff via email. Therefore, when each focus group commences it will be 'created' from within the school and the UOE will be invited in.

We want to minimise any potential disruption to the running of the school and the education of children. We will work closely with each school to ensure that disruption is minimised by facilitating any wish they may have regarding the running of this research. For example, they might choose specific times when they agree that pupils will be able to attend the focus groups. The research team will do everything it can to fit with the needs of the school.

- Questionnaires: The main questionnaires about primary and secondary outcomes of the
 project will be collected at baseline and end of the study, in the intervention and control
 groups. These questionnaires will be filled in by adolescents between 13-15 years old.
 Moreover, before focus groups ambassadors will answer a questionnaire about STEM
 interest.
 - This questionnaire for ambassadors will be sent by email to each ambassador to obtain their response before the day of the focus groups.
 - The format to distribute the main questionnaires to all adolescents' participants will be online, but ambassadors' inputs could be necessary to detect how to empower their peers to answer the virtual questionnaires of SEEDS.
 - After being included, each adolescent will receive a unique code to be used during all the project to avoid the inclusion of personal data in any documentation.
 - The file containing the association between name and code must be kept stored in a folder with restricted access to one person of the research group to ensure the confidentiality within the duration of the project, and it will never be shared with other institutions.
 - Each adolescent will have to introduce the corresponding personal code in the online questionnaire.

3.2.2. Informed consent procedures

The Consortium will ensure that the whole participants' recruitment procedure will be equitable and respect racial, ethnic, educational, socioeconomic and gender diversity, according to non-discrimination principles. The Consortium will respect cultural, religious, and linguistic diversity and will ensure/strive for equality between genders within the project activities.

Explicit informed consent by data subjects and their legal representatives is a vital part of any process involving human subjects, to respect their rights of free choice and to data privacy. The SEEDS Consortium will ensure that the potential subjects and their legal representatives can reach a truly informed decision about whether or not to participate in the research. Their explicit informed consent must be given freely, without coercion, and must be based on a clear















understanding of what participation involves, including any personal data to be processed and the purposes of the same.

Before getting the informed consents, research participants will receive information about the project aims, expected results and limits of the research, as letter of recruitment. The purpose is to ensure that participants fully understand the implications of being involved in the research. Participation in questionnaires and at the events in the project is voluntary and the participants will not be subject to any psychological, social, economic, or other form of risk.

All participants will also be informed that they may withdraw from the research process at any time during the project. If the research participant decides that they do not want to participate in the research process, for any reason, they will be always able to do it. In this document, there will also be information about the codification procedure that we are going to implement to guarantee the confidentiality of the data.

Informed consent forms for participating in the SEEDS will be included in the registration procedure for participants at all the four SEEDS pilot sites. The signature of the informed consent or the participants is a must before to be involved in the project. However, depending on the country partner, the signature of the legal representative will be required to be involved in the project (Greece, The United Kingdom and Spain) or only to be used for analyses (The Netherlands).

Different informed consents and letters of recruitment have been prepared depending on the principal actors in the SEEDS project:

- <u>High schools</u>: before starting to involve adolescents, the signature of the high-school responsible is needed.
- Adolescents (13-15 years): the signature of adolescents of the intervention group who will participate in the SEEDS makeathons interventions and adolescents in the control group will be needed before assessing baseline outcomes. Also, the ambassadors (adolescents who participate in all the research process) will have a specific informed consent that they must sign in before focus groups' participation.
- Parents: Regardless of the age, all pilot-countries will demand the informed consent signed for their parents to adolescent participants, considering that in some of the participant pilotcountries, parents must sign the informed consent if the adolescents have less than 16 years.
- <u>Stakeholders</u>: they must sign the informed consent before participating in the project.

The Consortium privacy policy and consent forms will be published in English on the project website and translated into Dutch, Spanish and Greek for the individual pilots.

A template of the informed consent form for data storage, collection, and processing in English has been prepared according to GDPR guidelines². A model is shown in **Annex 1**.

















Specific information about technical and organizational measures for safeguarding the rights and freedoms of subjects will be described in detail in Deliverable 6.3.

3.2.3. Anonymity of participants

Researchers will guarantee the confidentiality of data with the codification of the information related to the SEEDS participants throughout all the process and keep with restricted access the sensitive information without sharing among partners wish to hide for reasons of personal safety or privacy.

The procedures that partners will implement for the collection, storage, protection, retention, and destruction of data will comply with national and EU legislation specifically described in **D6.3**: **Safeguarding, freedoms and rights**, and in **D6.2 Data Management Plan**.

3.2.4. Compensation to participants

Compensation must be granted to all participants in accordance with general ethical principles, such as justice and respect (recognizing that their time and effort of participation is valuable and worthy of recognition), fairness and equity (all participants receive the same amount of compensation, and it must be reasonable and fair), safety protection (it must not increase participant's vulnerability or cause a disadvantaged situation for them), voluntariness (ensuring that participants are not unduly influenced into consenting to participate).

It is unconditional, cannot be regarded as a business transaction, and it has no obligation for the parties to provide any further services in the research.

The compensation of ambassadors, adolescents who participate in all the research SEEDS project, will consist in the possibility to travel to Brussels for the final dissemination meeting with all costs included.

The SEEDS participants did not receive any compensation for participating in the project. However, control schools will receive the material generated during the intervention to be able to implement part of the intervention, only if the intervention prove their effectiveness. Moreover, they will have the possibility to virtually participate in the dissemination session of the results obtained in the SEEDS project.

3.2.5. Minors' rights

A child is any human being below the age of 18 years old based on the Convention on the Rights of Child^{9.} The SEEDS project includes the participation of minors (13-15 years old) of disadvantaged neighbourhoods around Europe (Greece, Spain, The Netherlands and The United Kingdom). The rights of the child are part of human rights: rights that the EU and EU countries must respect, protect, and fulfil.

















Minors who participate in the project will sign an informed consent and also, their parents or legal representatives. Moreover, for assuring a higher quality implementation of the project and any conflict among the researchers and the minors, people in contact with minors needs, depending on the project, a certification of any legal and sexual crimes, as shown in Table 4.

This information is extended in deliverable 6.3.

3.2.6. Gender perspective

Gender perspective is a key aspect in the SEEDS project, and SEEDS Consortium will take all measures to promote and provide equal opportunities between girls and boys, and secure gender balance at all levels of the project.

SEEDS touches a range of gender-associated issues that involve misrepresentation of women in STEM careers, key role of mothers in nutrition in family units and the different strategies taken by boys and girls in tackling obesity. All these areas will be accordingly considered and assessed throughout the life cycle of the project.

Partners are also committed to assessing gender specific aspects of the project activities and research. This will include, but not limited to the following:

- To promote a gender-balanced structure of ambassadors and PhD students.
- To promote equal role of women in the leadership, design, and implementation of SEEDS interventions.
- To promote the participation of women as speakers in SEEDS events.

















 To identify possible gender-specific aspects linked to the research activities (i.e., analysing the impacts considering gender, the specific behavioural change, and the results in health and STEM outcomes).















4. CONCLUSIONS

This Ethics Management Plan describes the main procedures of the SEEDS project to operate based on ethics principles during all the research process and during all the SEEDS project implementation. The Ethics Management Plan aims to describe all the fundamental ethical issues relevant to the project and present all the procedures to be followed by all the SEEDS Consortium partners working in the project.

The Consortium carries out the project actions in compliance with ethical principles and applicable international, EU and national laws, and has also developed its own guidelines, procedures and measures aiming to support the protection of ethical aspects of research.

Phase 1: Protocol standardization & identification of pilot sites

Phase 3. Identification of adolescents' local needs & solutions

Process to identify adolescents' needs:

- Focus groups: Consist of a group interview (virtual or in person depending COVID-19 situation) with a duration of 75 minutes during school or extra school hours (depending on the availability of participants), where ambassadors and stakeholders will talk about needs, motivations and barriers found in adolescents' day-life to engage to adopt healthy lifestyles. Focus groups will be conducted with the ambassadors (4 to 6 adolescent ambassadors per session), and with local stakeholders identified by ambassadors (minimum 6 stakeholders) such as policymakers of the city, neighbourhood associations, business (i.e., gym, food stores, social communities, etc.), families or education professionals.
